The founding and parent organization within PMHFOS, **Passavant Memorial Homes (PMH)**, is a private, non-profit human service agency that provides residential, educational, recreational, vocational, and spiritual opportunities to those we serve within their local communities. With a strong emphasis on supporting individuals and their families in the achievement of personal goals, PMH encourages each person to reach their fullest potential.

Over the years, our organization has expanded through the development of a variety of subsidiary organizations: PDC Pharmacy, Life Enrichment Trust (LET), Accessible Dental Services (ADS), and Passavant Memorial Homes Foundation (PMHF). The subsidiaries were established to enhance the quality and accessibility of services for individuals and their families. Together, PMH and our subsidiaries are collectively referred to as PMHFOS.

About Our Subsidiaries

PDC Pharmacy was established to substantially improve the level of pharmacy services for individuals with intellectual disabilities. Unlike other long-term care pharmacies, PDC Pharmacy is solely focused on and committed to serving patients with intellectual disabilities, autism, and behavioral health needs. This unique focus provides PDC Pharmacy with the experience and resources to meet and exceed the specific needs of each patient that it is privileged to serve.

Life Enrichment Trust enables individuals with disabilities receiving Social Security, Supplemental Security Income, and/or Medical Assistance to secure their financial futures without endangering their source of monthly income, medical insurance, or other governmental benefits. LET's primary focus as a court-approved corporate fiduciary is to maintain the beneficiaries' eligibility and fully comply with all Social Security and Medicaid regulations and guidelines.

Accessible Dental Services provides superior, specialized dental services to individuals with intellectual disabilities, autism, and behavioral health needs in a safe and secure environment. As true specialists in providing dental care for those with disabilities, the experienced and compassionate ADS professional team recognizes and addresses the unique medical needs of each patient and provides comprehensive dental care of the utmost quality.

Passavant Memorial Homes Foundation was created to support PMHFOS and its commitment to enriching the lives of children and adults with intellectual disabilities, autism, and behavioral health needs. PMHF creates awareness of and provides additional financial resources for the quality programs of PMHFOS, which care for the physical, emotional, social, and spiritual needs of individuals while promoting choice and independence. PMHF upholds the contention that all people have the right to lead full, productive, and independent lives.
